## **Role& Responsibilities of SECOND PARTY**

- SECOND PARTY will provide the curriculum, study material of the training programme. The total hours of the module is 35 hours (including one day workshop)
- 2. SECOND PARTY will provide the necessary qualified and trained faculties for the training
- 3. SECOND PARTY will provide the course material in printed format to students.
- 4. The Online Support to the students will be given for mock test and practice tests.
- 5. One day (3 Hrs) workshop will be conducted to the beneficiaries with professionals practicing in Kozhikode to get the live environment in business and commerce.

### **Terms of Payment**

The vision of the MOU is to enable the commerce graduate to enrich the knowledge in accounting and enable them to be learn GST Compliances.. The course fee of the programme will be shared between both the parties on the following basis;

- The total fee is fixed as Rs. 1500/-(Rupees One thousand five hundred only) inclusive
  of GST 18 %. And an amount of Rs. 300/- (Rupees three hundred will be the exam fee
  inclusive of GST 18 %) will be given to the SECOND PARTY. The fee from students
  may be collected cash or UPI instalment according to the discretion of the
  INSTITUTION, as they wish.
- 2. The Second party will acknowledge the receipt of money and issue necessary receipt

#### **Other Terms and Conditions**
