3. An invigilator should be posted in the room and the Chief Superintendent should also keep vigilance over the room.
4. Remuneration @ ⁶⁶Rs. 22/- per day may be paid to the amanuensis.
5. Extra time @ 15 minutes per hour examination may be allowed to the blind candidates.

Blind candidates will be exempted from answering questions on drawing, graph, phonetic transcription etc. The answer books of the blind candidate must be packed separately and sent along with the answer books of other candidates.

The appointment of the amanuensis may be reported to this Office at the earliest.
