Phocess of Tea Manufacturing
Tea manufacture is the Process of transformation of freshly plucked green tea
leaves to black tea. There are several
olistinctive processes that take place in
the manufacture of black teas.

Plucking: The green deaf is harvested on a negular basis at intervals tranging from 5 days to 8 days brom each field. The Plucking of the Soft two leaves and the bud is generally undertaken by well trained women, because of the agility of Ferminine hands. The manufacture begins from the time leaf is plucked in the field and to ensure it retains its freshness the leaf is send to factories from the fields three to bour times a day.

Withering: - No sooner it is received at the factory, the leak is weighted and spread on thoughs. withering is a Process, where conditioned air is circulated between the leaves, initially to remove any surface moisture and thereafter to concentrate and

Chemically breakdown the I tea juices. It takes 10 hours to 14 hours for the Physical and chemical changes to take Place and bring the leap to soft and rubberry condition suitable for the next stage of namefacture.

Kolling: - The purpose of nolling is Primarily to break up the leaf cells on comparitments and to mix up the chemi-Cal components of the leaves with the enzymes. Various Eype of holletis atre used to achieve this objective. The First noll is often very gentle and known as the 'pre-conditioning roll'. The main action of the pre-conditioning noll has been found to be the gentle expression of the leaf juice on to the surface of the twisted particles. Subsequent nolling is Programmed to achieve a thorough breakdown of the leaf cells. A considera ble amount of heat is generated by Friction during the nolling Process, but care/must be exencised to ensure that temperature closs not exceed 350 bécause undesitable chemical and enzyme

heactions could occur at higher tempero

Fernentation :- Once the leaf is sifted through the noll Breaken, it is spread out on an even surface and left to allow Oscidisation. The Process of bernentation nephesents a series of complex chemial neactions which begin at the novement when the leaf is broken in the notless. The bareaking up of cells which causes the miscing up of the enzymes with the other chemical compounds within the cell nesults in a number of mactions; the most impositant being the oxidation of Polyphenols. An additional heaction that occurs during Fermentation is the tornation of some flavour compounds.

Drujing: - The Process of fining remover most of the leaves moisture and stops betweentation by destroying the enzymes. Further the flavour of the tea is balanced' during Firing because some of the lesser desirable law boiling compounds are removed thus accentuating the Presence of more useful higher boiling compounds.

Grading: - The dried tea leaves are Sorted into Particle sizes by sending them through Sifters that sift them through different meshes. This helps to categories the teas into the different grades - Dust, Pekoe, Bop etc.

Packing: - Teas are Very hygnoscopic and napiolly absorb moisture. when Sufficient quantities of teas are collected, they are either packed into Collected, they are either packs of Various Plywood tea chests of packs of Various Forms For direct distribution.
